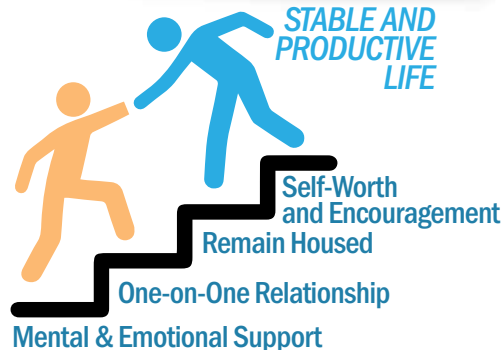

MANY PEOPLE IN OUR COMMUNITY LACK A **POSITIVE ROLE MODEL**

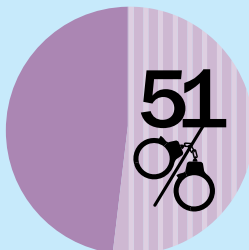
HOMELESSNESS

**1,599** homeless on any given night in Indianapolis  
**7,200** over the year  
Nearly **1 in 5** are fleeing domestic violence



RETURNING CITIZENS

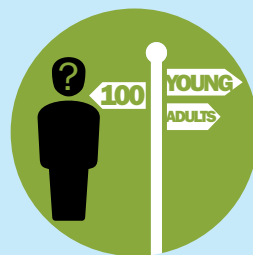
Over **5,000** people return to Marion County after leaving prison each year  
Without help, **51%** will re-offend within 3 years



Costs in excess of **\$25,000** to incarcerate one person for a year

YOUNG ADULTS AGING OUT OF FOSTER CARE

Every year, **100** young adults age out of foster care in Marion County. They face adulthood without a family to provide encouragement and guidance.



They are **25%** more likely to become homeless or be incarcerated.

Once in the system, these young adults can cost **\$300,000** per person in social costs over a person's lifetime.

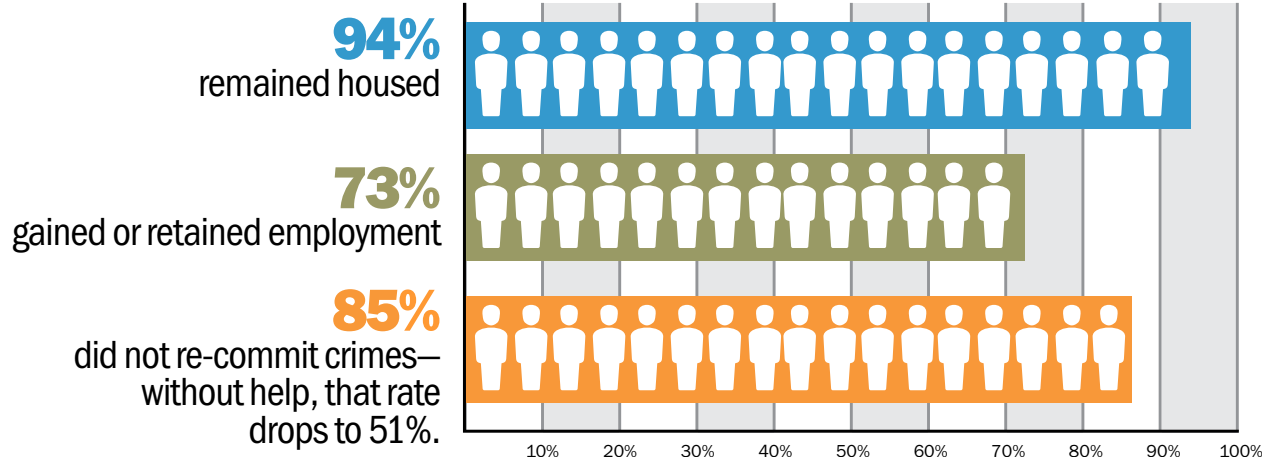
WHAT WE DO MAKES A DIFFERENCE

Trusted Mentors **recruits, qualifies, trains, and supports mentors** dedicated to helping individuals gain the necessary life skills to become self-sufficient along with a sense of self-worth.

**MENTORING**

- is not done alone – trained staff provide **on-going support**
- is provided by **volunteers**
- is a **one-on-one** relationship
- is **long-term**
- literally **changes lives**, and the face of our community
- **augments the value** of partner agencies' programs from which the individual is referred

We supported **171** mentor relationships in 2014 – up nearly 50 percent year over year.

Even a 1% reduction in the recidivism rate saves Marion County \$1.55 million.

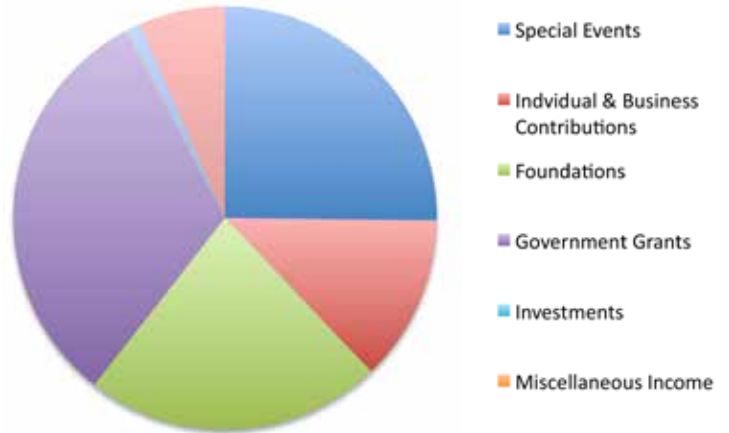
